

- ❖ The Quotations will be opened by Sr. Accounts Officer (Admin & Esstt) on 30.04.2024 at 3.00 P.M, in the presence of the tenderers or their representative who may like to be present.

The General Terms & conditions are:-

- ❖ It will be the responsibility of the vendor to pack the material by his own laborers and the cost towards Transportation, packing, Handling, Loading, Unloading, Weighing, etc. shall be borne by the successful bidder.
- ❖ The weighing of the material shall be jointly witnessed by an office staff of O/o CCA, M/o Chemicals & Fertilizers and the bidder or his authorized representative.
- ❖ The successful bidder will be responsible for collecting the aforementioned quantities of vouchers/big & small registers etc. from Office of Chief Controller of Accounts, M/o Chemicals & Fertilizers, 7<sup>th</sup> Floor, A-Wing, Janpath Bhawan, Janpath New Delhi-110001
- ❖ ***In case the successful bidder fails to lift the record within fifteen days from the date of issue of written communication, a sum of Rs.500/- per day shall be charged as a penalty from the successful bidder against non-compliance of order.***
- ❖ The old record i.e vouchers, registers etc. can be inspected during office hours prior to last date of submission of quotations.


