ORDER

Government of India has decided the movement of subsidised P&K Fertilizers through Coastal Shipping as an additional mode of transportation, to supplement the rail and road movement. The freight expenditure of Government under the subsidy regime, for coastal shipping will be restricted to primary rail freight on the basis of Railways receipt (RR) in case of de-controlled P&K fertilizers as per NBS w.e.f.01.04.2010 onwards. Accordingly, all decontrolled subsidised P&K fertilizers will fall within the ambit of Nutrient Based Subsidy Policy w.e.f. 01.04.2010, for domestic movement of the material through coastal shipping. The Standard Operating Procedure (SOP) will be as below:-

1. Coastal shipping is confined to domestic carriage of goods through coastal routes.

2. Carriage of cargo through coastal routes is permitted only on Indian Flag vessels. The bagged material is <u>containerized</u> before loading in the Indian sailing vessels and the containers are sealed in presence of the Indian custom authorities.

3. The fertilizer companies undertaking coastal movement are required to arrange the empty containers from the load port to their plant and the bagged cargo will be stuffed in the containers mounted on trailers. Thereafter the loaded containers are moved out to the port for loading on the vessels.

4. The containerized cargo is loaded in the Indian Flag vessels, licensed to move in the coastal routes and once the loading completes, the containers are sealed for moving the material directly to the discharge port with the sailing certificate issued.

5. A coastal bill of goods is generated for filing at load port, with the certification of Indian customs authorities after necessary inspection carried out by them. The same has to be cleared by the Indian custom authorities at the port of discharge.

6. On arriving at discharge port, custom authorities check and ensure the containerized cargo seals are intact and also verify the vessel's last port of call through the port clearance certificate. The cargo seal will remain intact till delivery at the warehouse.

7. After discharging the containers at the discharge port, custom documentation and seal verification of the goods is completed for loading the containers on trailers for moving to the warehouses. Seal intactness is again verified at the warehouse prior to breaking and de-stuffing the cargo.

8. For every movement of fertilizers through coastal shipping route from plant/port to finally in a district in any part of the country, a notional freight based on rail freight for movement of fertilizers from plant/port to the destination district will be worked out in the FMS.

9. The notional freight would be based on the estimated rail freight for movement of fertilizers from plant/port to the nearest railway rake point to the final destination district.

10. The notional rate should be computed automatically on FMS based on the final movement of fertilizers shown by the fertilizer companies on the FMS. For this purpose, the companies would provide the actual transportation cost details for the coastal shipping transportation at various stages on FMS.

11. The freight for movement of P&K fertilizers will be restricted to rail freight minus peak season surcharge to the nearest rake point to the final destination or actual freight incurred whichever is less.

12. Movement of fertilizer by coastal shipping would be strictly as per supply plan agreed by DOF and will be part of overall supply plan of month for a particular state, without +10% variation.

The FMS system has been modified to accommodate above changes. These orders will apply to the movement on or after date of issue of these orders.
