I. COMPANY PROFILE

Rashtriya Chemicals and Fertilizers Limited (RCF) was incorporated under the Indian Companies Act,1956 with the objective to carry on business relating to production and marketing of fertilizers, Industrial chemicals and derivatives.

The Company has two operating units - one at Trombay and the other at Thal in Raigad District. RCf is a schedule 'A'/ Navratna CPSE in Fertilizers sector with the administrative jurisdiction of Ministry of Chemicals & Fertilizers.

The company employed 2655 regular employees (Executives- 1332 and Non Executive 1323) as on 31.03.2023.

Its registered and corporate offices are in Mumbai, Maharastra.

The authorized and paid up capital of the company are Rs.800 Cr and Rs.551.69Cr. respectively as on March31, 2023.

The shareholding of the Govt. of India in the company is 75%. Disinvestment of 105 paid up equity out of Gol Shareholding in RCF through OFS is currently under process.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Marketing) is a member of the Board of Directors and reports to Chairman and Managing Director. He/ she heads the Marketing Division of the Company. He/ she is primarily responsible for marketing operations of the company, including formulation and implementation of the

marketing policies keeping in view company's profitability and objectives.
