GSR............. In exercise of the powers conferred by the proviso to article 109 of the Constitution and in supersession of the Ministry of Chemicals and Fertilizers(Department of Fertilizers), Assistant Commissioner (Shipping) Recruitment Rules, 2012, except as respective things done or omitted to be done, before such supersession, the President hereby makes the following rules, namely:-

- 1. Short title and commencement (1) These rules may be called the Ministry of Chemicals and Fertilizers (Department of Fertilizers), Assistant Commissioner (Shipping) Recruitment Rules, 2022
 - (2). They shall come into force on the date of their publication in the official Gazette.
- 2. Number of post, its classification and level in the pay matrix. The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in column (2) to (4) of the Schedule Annexed to these rules.
- 3. Method of recruitment, age limit, qualification etc. The method of recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in the columns (5) to (13) of the said Schedule.

4. Disqualification. - No person,-

(b) Who has entered into or contracted a marriage with a person having a spouse living;

or

(b) Who, having a spouse living, has entered into or contracted a marriage with any

person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under

the personal law applicable to such person and the other party to the marriage and that there are

other grounds for so doing, exempt any person from operation of these rules.

5. Power to relax. - Where the Central Government is of the opinion that it is necessary or

expedient so to do, it may by order and for the reasons to be recorded in writing and in

consultation with Union Public Service Commission, relax any of the provisions of these rules

with respect to any class or category of persons.

6. Saving. - Nothing in these rules shall affect reservations, relaxation of age-limit and other

concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-

Servicemen and other special categories of persons in accordance with the orders issued by the

Central Government from time to time in this regard.

Note 1: The Departmental Assistant Director(Shipping) with four years regular service in the grade shall also be considered along with deputationists and in case he is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

Note 2: Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors would also being considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher level along with their junior who have already completed such qualifying or eligibility service.

- or Deputy Secretary (Administration) Member

Public Service Commission necessary on each occasion.

Note 3: For the purpose of computing minimum qualifying service for promotion. the service rendered on a regular basis by an officer prior to 01-01-2006, the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission. The Departmental Officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation or absorption. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Period of deputation(including short term contract) including period of deputation(including short term contract) in another ex cadre post held immediately preceding this appointment in the same or some other organisation or Department of the central Government shall ordinarily not to exceed four years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.

Note 4: For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 01-01-2006, the date from which the revised pay structure based on the 6th CPC recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the pay commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where the benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.

- 1. Short title and commencement (1) These rules may be called the Ministry of Chemicals and Fertilizers (Department of Fertilizers), Deputy Commissioner (Port, Operations & Project) Recruitment Rules, 2022
 - (2). They shall come into force on the date of their publication in the official Gazette.
- 2. Number of post, its classification and level in the pay matrix. The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in column (2) to (4) of the Schedule Annexed to these rules.
- 3. Method of recruitment, age limit, qualification etc. The method of recruitment to the said post, age limit, qualifications and other matters connected therewith shall be as specified in the columns (5) to (13) of the said Schedule.

4. Disqualification. - No person,-

(a) Who has entered into or contracted a marriage with a person having a spouse living;

or

(b) Who, having a spouse living, has entered into or contracted a marriage with any

person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under

the personal law applicable to such person and the other party to the marriage and that there are

other grounds for so doing, exempt any person from operation of these rules.

5. Power to relax. - Where the Central Government is of the opinion that it is necessary or

expedient so to do, it may by order, for the reasons to be recorded in writing and in consultation

with Union Public Service Commission, relax any of the provisions of these rules with respect to

any class or category of persons.
